



PRIVACY POLICY

My IT Team, LLC (“My IT Team” or “Company”) has a strong commitment to protecting the privacy of its customers and visitors to its website. This Privacy Policy is intended to describe what information the Company collects from its customers and from visitors, and how the Company uses that information once it is collected. This Privacy Policy applies to any visitor or user (hereinafter referred to as “You”). By visiting the Website, you (the “User”) agree and accept the provisions of this Privacy Policy as a condition of your continued use of the Website.

APPLICATION OF THIS POLICY

This privacy policy applies to the My IT Team, LLC website located at <https://www.myitteam.pro> and any other website of an affiliate or subsidiary of My IT Team, LLC (each singularly and collectively referred to as the “Website”). This policy does not apply to any websites owned and operated by third party suppliers, manufacturers or distributors, even if such websites link to the Website or the Website contains links to those websites.

COLLECTION OF DATA

In most cases, we anonymously collect information about your visit when you use this Website. If you browse the Website without inputting any information or without having communicated with the Company through electronic mail, you do so anonymously. We do not collect your electronic mail address or other personal information unless you actively submit that personal information to us or communicate with us through an electronic mail message. In most cases, we may anonymously track your IP address (the internet address of your computer) and other information that we may use to analyze elements of your visit that are required to create a better experience for you, including, without limitation, the state and/or country you are accessing the internet from, the date and time you visited and the type of computer, and operating system and Web browser you are using. Your browser supplies us with much of this information. We do not link your IP address to anything personally identifiable unless you first provide us with information that personally identifies you. We use this information from our server logs to learn more about our visitors. The information helps us identify overall usage patterns and trends on the site.

EXAMPLES OF THE TYPES OF INFORMATION THAT WE MAY COLLECT

IP Addresses: An Internet protocol address, or IP address, is automatically assigned to your computer when you access the Internet and is used by web servers to identify your



computer. When you access our website, we may log your IP address; however, your identity will remain anonymous to us unless you input information to our Website that enables us to personally identify you or in the event that you communicate with us through electronic mail. We log the IP addresses for system administration and for auditing the use of our Site. We may also use IP addresses to collect statistical information for marketing and other purposes.

Cookies or Tracers: From time to time, we may place information on your computer to allow us to identify you. This information is known as a “cookie”. Cookies are small files which are stored on your computer to keep track of your visit to the website and your preferences; as you move between pages, and sometimes to save settings between visits. Cookies help the builders of websites gather statistics about how often people visit certain areas of the site and help in tailoring websites to be more useful and user-friendly. The cookies we store on the Websites are used to: (a) track the number and type of visits to the Website and its pages in order for us to determine which parts of the site are working well and which need improvement, (b) store your preferences for screen layouts including your preferred language and country, (c) gather statistics on the number of users and their usage patterns, and (d) improve the speed and performance of the website pages. We will only use cookies to view information on the User’s computer’s hard drive that was placed there by a cookie from our website, such as your preferences or which pages you have visited on the Website. However, a cookie will not allow our website to learn any personally identifiable information that you have not otherwise disclosed (except as described below). By understanding how and when our visitors use the Website, we can continually improve our website, as well as our products and services. You may opt-out of cookies (and the use of this website) at any time, by deleting the cookies that were set by the site. This can be done via the settings of your internet browser and deleting all cookies.

Web Beacons: Web beacons are small files that we may place on our website, which count the number of unique users that have visited a specific page on the Website and the number of times a given page has been displayed. This information is collected only in the aggregate and is generally not linked to any personally identifiable information unless you provide information to us that enables us to personally identify you or if you communicate with us through electronic mail.

USE OF INFORMATION

Anonymous data collected using cookies and web beacons as well as other methods and tools may be analyzed in the aggregate to determine collective user characteristics, to understand user traffic patterns, sales information and user behavior on the Website. In the



event that you have input information to us that personally identifies you, such as by inputting that information into a form on the site or via an electronic mail communication, we may link your IP address to you as an individual and identify you and the data we collect and track on your usage. However, any analysis that we do on your usage or visit will be for internal purposes only.

We use any information collected to enhance the quality of the products or services we wish to provide to our customers. We restrict access to personal information about you to those employees, agents or other parties who need to know that information to provide products or services to you or in connection with your investments with or through us. We maintain physical, electronic and procedural safeguards to guard your personal information, including firewalls, individual passwords and encryption and authentication technology. We do not use it for purposes other than as set out above, or disclose to any third party any personal information about our customers or former customers, except with such customer's consent or as otherwise permitted or required by law.

We may also disclose this information to firms that perform services on our behalf to the extent permitted by applicable law. The Company does engage third parties to assist us in the analysis and tracking of your visit to the Website. However, we do not disclose your identity to any third parties.

COLLECTION OF YOUR PERSONAL INFORMATION

Certain features and functions offered via the Website or from other solicitations of the Company enable potential customers or interested individuals to submit personal or business information to the Company. For example, the Website may contain a form where you can input information, or you may send a communication to us by electronic mail. We may use this information to analyze various parameters of your visit to the Website and even to provide various products and services to you. The Company will not share your name, address, e-mail address or other personal information with any other organization, unless it is necessary to: (a) satisfy a legal order or comply with legal process; (b) defend the rights of the Company or its affiliates or business partners; or (c) protect the personal safety of Company employees, agents, affiliates, business partners, customers or Website users.

SECURITY

Please note that data that is transported over an open network, such as the Internet or e-mail, may be accessible to anybody. The Company cannot guarantee the confidentiality of any communication or material transmitted via such open networks. When disclosing any



personal information via an open network, you should remain mindful of the fact that it is potentially accessible to others, and consequently, can be collected and used by others without your consent. In particular, while individual data packets are often encrypted, the names of the sender and recipient are not. Even if both the sender and recipient are located in the same country data may also be transmitted via such networks to other countries regularly and without controls, including to countries that do not afford the same level of data protection as your country of domicile.

Your data may be lost during transmission or may be accessed by unauthorized parties. We do not accept any liability for direct or indirect losses as it regards the security of your data during its transfer via Internet. Please use other means of communication if you think this is necessary or prudent for security reasons. This website has reasonable technical and organizational security measures in place to protect the loss, misuse or alteration of information under our control. We cannot guarantee that unauthorized third parties will never be able to defeat those security measures.

PRIVACY POLICY CHANGES

The Company reserves the right to change its Privacy Policy at any time without prior notice. Any changes to the Privacy Policy will be posted on this page and will be effective immediately upon posting.

EXTERNAL LINKS

Occasionally, you may find links from our website to independently owned, controlled, and/or managed websites whose content we believe will be of possible interest and value to our visitors.

In many cases, these links represent cooperative projects or mutual links established with the organizations connected with these sites. We don't control the content of the sites accessed by you via these links. These other sites may send you their own cookies, collect data, or solicit personal information.

Once you leave our servers (you can generally tell where you are by checking the URL in the location bar on your browser), the use of any information you provide is governed by the privacy policy of the operator of the site you are visiting. That policy may differ from ours. GOVERNING LAW
